1. Deputy Chairman's Address - Roger

- Main Committee. In February, after three years in post, Chris and Lyn will be standing
 down from their positions as Chairman and Secretary. These and other Main Committee

It was suggested that in future, individuals paid their own entry into relay events to be re-imbursed by the club once they have completed the event. This suggestion will be considered by the Main Committee.
